By submitting the entry form via email Teachers are agreeing that all entry monies will be paid with regards to their school.

We urge all Teachers to make their parents aware that if they no longer attend the Feis, their fees including registration fee will go towards the Neo Natal Intensive Care Unit Altnagelvin Hospital.

Please be aware It is a huge undertaking to run a feis in these circumstances and all costs must be covered.

CORONAVIRUS FEIS GUIDELINES

- 1. Entries must be submitted by Teachers with Parental consent to comply with all guidelines in place with Covid-19 Regulations.**
- 2. A Covid-19 Declaration form MUST be completed, signed, and produced before entry to the Event will be permitted. All forms will be collected by Teachers at the point of entry.**
- 3. Entry & Exit points will be manned at all times.**
- 4. Entry will be restricted to 1 parent/guardian and 1 dancer. A parent with more than one sibling competing in the same age/session should be noted on the entry form. Seating will be provided.**
- 5. The Stewards will ensure the use of hand sanitizer at the entry point.**
- 6. Hand sanitizing stations will be made available in various locations throughout the event.**
- 7. Temperatures will be taken at point of entry.**
- 8. There will be a one-way system of entry and exit in place. This will be strictly enforced.**
- 9. Face masks must be worn at all times, unless exempt for medical reasons – proof will be required.**
- 10. Dancers to come dressed, with hair and make-up done before arriving at the Event.**

11. Dancers over 12yrs must wear masks while seated or moving throughout the venue but may be exempt while dancing.
12. Dancers will be called up in small groups and be socially distanced when lining up to dance.
13. Dancers will be socially distanced during prizegiving. Podiums will be placed according to guidelines in place.
14. Seating in the venue will be socially distanced in accordance with Covid-19 Regulations.
15. No food or hot beverages will be allowed in the hall. Water/drink for dancers is permitted.
16. Please bring own rubbish bag, to be taken home when the session ends.
17. The Audience MUST remain seated at all times.
18. Seating/contact surfaces will be cleaned at the end of each session.
19. All prizes will be sanitized prior to the event and subsequently be handled by prize givers who will wear facemask and gloves. These will be changed regularly.
20. The microphone should only be used by the MC and cleaned regularly.
21. A safe area will be available to facilitate isolation for anyone who is unwell with Covid-19 symptoms while awaiting medical attention.

22. As per government regulations, anyone over the age of 18 must produce a digital Covid-Cert or a negative Antigen/LFT (this test must have been performed within 48 hours of attending the feis.



Rules of the Feis

- **Confined Reel – confined to all dancers who have not yet won a 3 Adjudicator Championship.**
- **Dancers may only compete in ONE Reel Cup competition.**
- **Dancers may only dance in one grade per dance.**
- **The Championship Under 9 involves 2 rounds (solos are incorporated into the Championship) and adjudicated by 1 adjudicator.**
- **The Championships from Under 10 to Senior involve 2 rounds (solos are incorporated into the Championship) and adjudicated by 3 adjudicators.**
- **Solo costumes may not be worn in any competition up to and including Under 9.**
- **No changing of costumes in any location within the Diamond Centre.**
- **No dancer to dance anywhere other than on the stage.**
- **Facial make-up may not be worn in any competition up to and including Under 12.**
- **Age as determined on 1st January 2022.**
- **No photography to be used during competitions either by video, mobile phone, or camera.**
- **The front row is reserved for qualified Teachers (TCRGs)**

A. Declaration

By signing this form, I declare that:

1. I have not been diagnosed with COVID-19 within the past 10 days.
2. I am not experiencing symptoms of COVID-19 (i.e. new cough OR change to taste/smell OR temperature $\geq 37.8^{\circ}\text{C}$).
3. I am not awaiting a COVID-19 test result, nor do I reside with a person who is awaiting a COVID-19 test result.
4. In the preceding 10 days, I have not been in close contact with a person who has been diagnosed with COVID-19, or a person who is awaiting a COVID-19 test result.
5. I do not reside with a person who:
 - a. has been displaying symptoms of COVID-19 OR
 - b. has been diagnosed with COVID-19 and is currently under quarantine
6. In attending this event, I have followed all travel guidance as per authorities in both Northern Ireland and my own jurisdiction.
7. I am aware of the most recent travel guidelines issued by the Northern Ireland Government (and within my own jurisdiction if applicable), and confirm that I have not undertaken any recent travel for which I should currently be under quarantine as per this guidance.
8. I take responsibility for any child/ren attending The SCBU Feis under my care; and on their behalf, confirm the above points 1-7 is true for them also.

B. Consent:

By signing this form, I give the Derry/Donegal Branch of An Chomhdháil permission to use the information I have provided on this form for the purposes of contact tracing.

C. Acknowledgment

By signing this form, I acknowledge that:

1. I have read and agree to the Feis rules and Covid guidance stated on the syllabus.
2. I must wear a face covering at all times while inside the building.
3. Strictly one parent/guardian per dancer permitted entry to the hall.
4. I must adhere to all Government guidelines, including social distancing and hygiene measures.
5. Where it is deemed necessary, the information I have provided on this form may be provided to other entities for the purposes of track and trace.
6. I will not be admitted to the premises if:
 - a. I have been diagnosed with COVID-19 within the past 10 days.
 - b. I reside with a person who has been diagnosed with COVID-19 and is still under quarantine.
 - c. I am awaiting a COVID-19 test result, or I reside with a person who is awaiting a COVID-19 test result.
 - d. In the past 10 days, I have been in close contact with a person who has been diagnosed with COVID-19 or is awaiting a COVID-19 test result.
 - e. I am experiencing symptoms of COVID-19.
 - f. I have a temperature of 37.8°C or greater when checked at the point of entry.
 - g. I have undertaken travel for which I should currently be in quarantine as per most recent Government guidance.
7. I will be required to leave the premises if:
 - a. I develop symptoms of COVID-19.
 - b. I fail to comply with Public Health Advice, or rules and Covid guidance as stated by the Branch.
8. In the event of refusal of entry or requirement to leave the premises, there will be no refund of entry fees.

D. Waiver of Liability and Assumption of Risk

In consideration of being allowed to participate in The SCBU Feis 2022, the undersigned acknowledges and agrees that:

Attendance at this event includes possible exposure to an illness from infectious diseases, including but not limited to COVID-19. While particular rules and personal discipline may reduce this risk, the risk of serious illness, injury, and death does exist despite precautions that are taken.

By attending The SCBU Feis;

I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, both known and unknown, EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others, and assume full responsibility for my participation.
